Terms of Reference

The scholarships are offered for achievement to those students who have completed one full year of university/college level courses, have attained a minimum academic average of 65% or 2.5 grade average and are enrolled as a second year student at a Canadian University or College.

Deadline for Applications: May 5th, 2018

Announcement of Winners: By September 1, 2018

Sponsor: Responsible Distribution Canada (RDC) Education Fund

Award: \$1,000 per scholarship. Maximum of three awards.

Eligibility: Nominees must be children of RDC'S Member Company (in Good Standing) employees. They must be continuing and registered in an education program at a Canadian university or college for the Fall of 2018. Up to three scholarships are presented annually by the RDC, unless the Committee establishes that no suitable nominees exist in a given year. The Student's transcript must demonstrate a minimum academic average of 65% or 2.5/4.0 for the last two post secondary semesters. All applications will be combined and the winners will be selected in a lottery format.

Nomination: Nominations are accepted by email in a .pdf format to the Responsible Distribution Canada Scholarship Committee Chair at suzanne@rdcanada.ca or mailed to the RDC Scholarship Committee, 1160 Blair Rd., Unit 1, Burlington, ON L7M 1K9.

You must include:

- Scholarship Application;
- Covering Letter / request from the student, outlining the reason for applying and career aspirations;
- Unofficial transcript of the student's academic record for the last two post secondary semesters (Fall 2017 & Winter 2018).
